Further, the owner/tenant indemnifies the scheme against any claims by 3rd parties related to any damage or injury caused by the animal, reptile or bird and the owner agrees to immediately remove the said animal, reptile or bird if proven dangerous.

1. The animal, reptile or bird is allowed out of the owner's private property only when under the control of a responsible adult – dogs must be leashed;
2. the animal, reptile or bird is not allowed under any circumstances to enter any other owner's private property without the permission of that owner.
3. If the animal, reptile or bird should soil or damage any part of the property, the owner shall immediately clean up and / or repair such mess and / or damage to the satisfaction of the governing body so that the area is made good and / or left in a clean and hygienic state.
4. The animal, reptile or bird is not allowed to create a nuisance or disturb other owners / occupants by excessive barking, howling etc. – undue nuisance will result in the withdrawal of permission to keep the pet under complaint. The owner / tenant to undertake that this be monitored.
5. The area in which the animal is kept must be maintained in a neat and clean state and must not, under any circumstances, have an adverse effect on neighbouring properties either from an aesthetic or a hygienic

aspect. The owner / tenant must undertake to apply a high level of preventative health, such as undertaking regular flea or worm treatments and so on.

It is the responsibility of the owner to ensure that the tenant(s) are made aware of these requirements. The application hereby also acknowledges that, in the event of the death of the pet for which permission is applied for herewith, a replacement pet may not be kept under this application.
